Any bids received later than the above time will be returned unopened.

DESCRIPTION OF WORK: The maintenance and reinforcement of the Bid Monon Ditch includes but is not limited to:

- Using riprap to stabilize the toe and bank.
- Using riprap to fix and stabilize the rock chute areas that have been eroded.
- Protecting the waterway and surrounding wetlands to minimize the construction impact.
