The Lady Warriors had a mighty exhibition placing four runners in the top 5 and seven in the top 10 on the way to a 20-39 victory. Kate Collins led the way, breaking the tape first, followed by Maggie Smith in third place, Kelsey Wegner in fourth place and Alexis Sheets in fifth place.

Rounding out the top 10 runners were Kingsley Kroft (7th), Rori Blackman (9th) and Bethany Poor (10th). Also, finishing the race for Winamac were Emily Rausch, Lily Bennett and Ariana Gualajara.
